7.1 President's Report

 In addition to the published report included as part of the 2017 Semi-Annual Meeting package, President Walker highlighted the following items:

High Performance External Review:

• The Board determined that a summary report on the High Performance External Review would be communicated initially to RCA National Team athletes and coaches. A report to the membership will be provided soon.

Canadian Rowing Hall of Fame (CRHF):

- On Friday January 27th Rowing Canada Aviron celebrated the inductions of Marnie McBean, Kathleen Heddle and Frank Read to the Canadian Rowing Hall of Fame's Inaugural Class. This is in addition to the Paris Crew, Ned Hanlan and Claude Saunders, inducted in August at the 2016 Royal Canadian Henley Regatta. The CRHF Committee were thanked for their excellent work on this project.
- Members were also invited to submit nominations to the CRHF Class of 2017 nominations close on January 30, 2017.

Award's Program:

 The RCA Award's Program was streamlined this year, with some athlete and coach awards given out in front of their peers at other events such as the RCA National Rowing Championships.

RCA Board of Directors Update:

- Joel Finlay resigned in early 2016 and was replaced on the Board with the appointment of Tom Hawker. Rick Crooker's term as Director ended on September 15th. Tom Hawker and Ian Gordon were elected to the Board at the Annual Meeting in September along with Carol Purcer, re-elected as Provincial Director.
- President Walker was also sad to report that Director Brian Lamb passed away on January 27th.

• This is Donna Atkinson's last meeting as CEO. Terry Dillon will be taken over that role at the close of this meeting and will work with Donna on a smooth transition.

RCA National Conference:

• For the very first time, RCA's National Conference was held in conjunction with the 2017 World Rowing Coaches Conference, an event that included participants from as far away as Australia and eastern Europe.

IOC:

 It was noted that former National Team member Tricia Smith was elected to the International Olympic Committee in addition to her roles as President of the Canadian Olympic Committee and Vice-President of FISA.

FISA:

 The RCA Board met with FISA's Executive Committee during the National Conference. The agenda for the upcoming FISA Extraordinary Congress was discussed including the 2020 Olympic Rowing Program.

Olympic Results:

 National Team results at the 2016 Olympics were disappointing but RCA is moving forward with its program for 2020 and 2024 and recommendations from the external High Performance Review are being implemented.

There was a question regarding the publishing of the High Performance External Review.

It was noted that the full report will not be published because of priviacy issues, but a summary report on the findings and recommendations will be provided to the membership.

There was a question regarding a new training centre at Quamichan Lake on Vancouver Island.

- It was noted that the project is under review but there is there is strong support for having one National Team training centre.
- There is a water quality issue at Quamichan Lake in Duncan that needs to be resolved before the project can continue.

6.2 Chief Executive Officer's Report

CEO Donna Atkinson reflected on her career with Rowing Canada:

- Brian Lamb was remembered for all of the support he provided during the past 6 years.
- There were major changes to RCA Governance along with many other initiatives such as the 2015 Pan Am Games Regatta in Toronto and the FISA Masters Championships.
- Donna thanked the members, board and staff for their encouragement and assistance during her time with RCA.

There was a question regarding the Talent Identification Program (TID), this was not included in the Annual Report. This involves many provincial coaches and there were issues with the program's management that need to be fixed:

- It was noted that TID includes partnerships with provincial rowing associations and it is part of the Row to Podium (RTP) program. Funding is provided by RTP to RCA RCA provides support to the provinces based on those funds.
- TID is part of the High Performance External Review and it will be included in the summary findings provided to the membership.

6.3 Treasurer's Report

- There was a correction on Page 8 of the Annual Report under the Treasurer's Report, last paragraph should reflect a net loss of \$5,679.
- On the audited financial statement, Statement of Operations, this reflected a net of \$1,102, based on event profits, reimbursement for consultant services and reduced salaries as a result of partially filled positions.
- Unrestricted equity position is \$459,398.
- Cash resources appear to be down for the year, and this mainly due to the timing of funds received from the COC.
- \$81,243 in expenses are included in Communications and Marketing are offset by funding as a result of an NST Enhancement Agreement with the Canadian Olympic Committee. These expenses went to the advancement of RCA's fundraising program and to the development of the Canadian Rowing Hall of Fame.

6.4 RCA Committee on Dues and Fees Report

- The Committee on Dues and Fees report was reviewed at the RCA Plenary Session on Saturday afternoon.
- George Barkwell was Acting Chair in the absence of Michelle Kerr.
- The Committee discussed the pending new Membership Fee Structure and the transition from the current fee structure to the proposed new system. The history of fee increases was examined and the fact that the Competitive fee had increased by \$8 over the past 8 years while the Sport fee had only increased \$3 in the same time period was noted. It was discussed and agreed that inflationary increases needed to be covered by the members.
- The Committee, after two lengthy conference calls, was unanimous in its recommendation to the membership that the Sport Rower fee be increased to \$15 and, all other fees to remain the same for the 2017-2018 registration year.

It was noted by the Committee that revenue is flat and to deal with rising costs and inflation, an increase was warranted to avoid having to plan for a deficit.

Question:

Has the Committee considered having a cost of living increase each year to avoid having one large increase.

The Committee reviewed the impact on clubs related to fee increase and considered a long term plan. After this review the Committee recommended to management the need to have 3 to 5 year financial projections. This would improve the Committee's ability to plan for fee increases.

Question:

The new RCA Umpire Education program was mentioned in the Annual Report but was not launched during the conference.

A communication on the Umpire Education Program will be sent out soon.

By-Law Amendment – Paragraph 11.1

It is stated in Paragraph 11.1 of the CARA By-laws that the Nominating Committee must include a member of the Board who shall serve as Chair.

Having reviewed the Paragraph 11.1 at the Board Meeting held on May 7th, 2016, it was agreed that a member of the Board must be included on the Nominating Committee, but it could be impractical for that member to serve as Chair for purposes of continuity on the Committee.

As a result, in accordance with Section 25 of the CARA Bylaws, the RCA Board of Directors has by Special Resolution passed the following motion that changes <u>Paragraph 11.1 Nominating Committee</u>, and this motion is provided for ratification by the RCA membership at the 2017 Semi-Annual Meeting:

9. Other Business

9.1 Report and Recommendations – Membership Category Working Group

In September 2016, Members received a document entitled <u>"Proposal for a New RCA Membership Model"</u> and were invited to provide feedback. 107 responses to the survey were received from Member Organizations.

The proposal contained four key principles on which the proposed new membership structure was based as well as six recommendations:

The PRINCIPLES of the Proposed Membership Model are:

- 1. All Canadian rowing participants (currently "sport" and "competitive" rowers) would be registered with RCA when they enter any program at the club level and, pay the same "base member" fee.
- 2. All events (e.g. regattas) conducted by our member organizations must be sanctioned by RCA/PRA.
- 3. All event organizers would use the same registration system (RegattaCentral) to set up their event and accept registrations.
- 4. All participants (including non-Canadian) competing in a sanctioned event would pay a seat fee levied by RCA. Individual provinces may also elect to levy seat fees for each regatta hosted within that province.

The RECOMMENDATIONS of the Membership Category Working Group were:

- 1. Adopt a "per seat" fee system.
- 2. Adopt an RCA base fee of \$20 and an RCA per seat fee of \$3.25/seat in year one (2018).
- 3. That Indoor Rowing events be included on the basis of paying the "per seat" fee.
- 4. That the committee reviews more specifically the category of RCA coach membership, examines how this is done across other sports, and recommends a strategy to ensure the proper registration of all club coaches across Canada.
- 5. That prior to implementation of the new member registration system and policies in 2018, member benefits (e.g. clothing and other supplier discounts) be negotiated to provide an incentive-based system that supports our members.
- 6. That a "supporter package" be developed and launched at the same time as the new registration system.

Based on the survey feedback received from the membership, all six recommendations were supported by a majority of respondents. In terms of recommendations #5 and #6 these were considered positive steps by most but were not necessarily a high priority. Concerns were raised that these should not be implicitly tied to implementation of the new system, being too resource intensive or, taking away from other RCA priorities.

Therefore, as approved by the RCA Board of Directors, the Membership Category Working Group recommends:

- *Approval of the PRINCIPLES and RECOMMENDATIONS 1-4, as outlined in the <u>"Proposal for a New RCA Membership Model"</u>, for implementation April 1st, 2018.
