6.2 Approval - Extra Provincial Registration - RCA

• The Province of BC will not accept vehicles for registration owned by a nationally incorporated organization. As a result, RCA has had to register its vehicles in the names of RCA staff which is not

Improvements - London Training Centre

- Additional boat storage area on the existing concrete pad if variance permit from the City/Conservation Authority can be obtained. A plan B is being looked at if this cannot happen
- a wall to be moved to improve the change room facilities/shower area for LTC women
- a new dock area is to be added
