## RCA PRESIDENT REPORT

Reflecting over the past 12 months, it has been a year of adaptation, innovation and a willingness to look at rowing through a different lens as we endeavoured to stay connected throughout the year. The COVID-19 pandemic continued to curtail activities outside of our homes but that didn't curtail new thinking!

Nationally, RCA launched The Great Indoors, which included six weekly challenges to motivate indoor rowers. The RCA Indoor Rowing App was developed and initiated to encourage participation by including instructional videos for new indoor rowers and training plans for active indoor rowers! These training initiatives led to the virtual rowing competitions that were unique and well received. The Canadian Indoor Rowing Championships, the Row to Tokyo Team Challenge and the Cascadia RCA Masters Challenge engaged rowers of various levels to compete while we were confined to homes during the pandemic.

As we returned to the water, the RCA Beach Sprint Trials were established, a three-part series launched in Nova Scotia, to Ontario and culminating in British Columbia resulting in three Canadian athletes qualifying for the World Beach Sprints in Portugal! Congratulations to Brienne Miller who brought home a gold medal in the women's solo (CW1X) event!

More on water opportunities began to open up in August and a number of regattas gave seasoned rowers and novices alike opportunities to enjoy rowing on the water again. The fall season incorporated fun regattas for novices and competitive regattas as well, culminating with the National Rowing Championships in November in Victoria. The RCA Emergency Relief Fund and recovery grants were beneficial to a number of clubs across Canada for a variety of purposes - each to fit the needs of the club. Also, they supported new initiatives to encourage more people to row. The Coastal Rowing Development Project at the Kingston Rowing Club, the Oar Board initiative at the Toronto Argonauts Club and the Community Rowing Program at the False Creek RC in Vancouver were outreach programs that garnered new participants to our sport.

RCA CEO, Terry Dillon captured, in his report, our collective sentiments of pride for our Olympic and Paralympic teams this year along with our NextGen teams who represented Canada so well on the world stage.

In closing, thank you to the RCA staff who work tirelessly to create, rework and refine services and products that bring us closer together. Also, congratulations to the rowing communities across Canada for their perseverance through this pandemic. Complicated processes, varying government guidelines and this persistent virus have made access to our favourite sport difficult but not unachievable. Thank you to all for pulling your oar through the water to grow rowing in Canada.

## CEO REPORT

Throughout the last several months, we have seen the most amazing generosity and spirit from our community. The harsh realities of dealing with the impact of COVID-19 could have pulled us apart but has in fact brought us closer together. If there has been a positive outcome from the pandemic it has been an increase in collaboration between Rowing Canada Aviron, our Provincial Rowing Associations, and our Member Clubs.

As we reflect on the work that was done this last year, there are too many people to recognize here, but I must mention Dr Mike Wilkinson and Jen Fitzpatrick, for their tireless support in helping our community navigate the pandemic. We saw more than 90 of our 130 members able to run programming at a time when many other organizations were unable to operate. **Everyone deserves a medal for what it took to navigate the last 18 months.** 

Speaking of medals, it has been a summer of success both in Tokyo, at the U23 and U19 World Rowing Championships, and, more recently, for Brienne Miller, at the World Rowing Beach Sprint Finals in Portugal. It is particularly pleasing to see our NextGen men excel with success in the U19 pair in Plovdiv, and the U23 four in Racice.

I know we all feel proud of our Tokyo athletes, for their performances and for the medals that they brought home. We qualified the largest team since 1996, and then navigated a pandemic, dealt with a postponement of the Games, and were still able to show up on the start line as well prepared as any team—an incredible achievement which was only possible because of the commitment and effort of a talented and tireless coaching team and support and leadership from RCA's high performance staff. We watched many memorable performances, but special congratulations go to our gold medal winning women's eight and bronze medal winning women's pair. It was especially pleasing to see Michelle Darvill, coach of the women's eight, be recently named Coach of the Year by the Coaching Association of Canada.

As we look forward as a sport, we are excited about a set of Strategic Priorities that will see a focus on growth and a diversification of our sport. The consultation and work we did this last year have made it clear there is an appetite and commitment from our membership to embrace new disciplines, such as coastal, beach sprints, indoor, and virtual rowing. We have laid the groundwork, through the Safe Sport Framework and the Every Coach Certified initiative, for a safe and more inclusive sport, where athlete wellbeing is central to how we operate.

I would like to thank the Rowing Canada Aviron Board for their support and vision, and our President, Carol Purcer for her wisdom and her tireless leadership. It has been a pleasure to work with a group aligned around a direction and so prepared to challenge the status quo.

I would like to acknowledge and thank all our RCA staff and my team – Jen Fitzpatrick, Adam Parfitt, and Kim Bell – without whom I couldn't hope to do my job. It has been difficult and challenging but continues to be incredibly rewarding.

Finally, I want to recognize that rowing in Canada can only operate because of the countless hours given freely by volunteers – the coaches, the officers, the officials, the umpires – all of you that make the running of our clubs and events possible. I am looking forward – as I know we all are - to not just seeing us all in little "zoom boxes", but actually spending time with everyone again!

## **REASURER'S** REPORT FOR THE YEAR ENDED - MARCH 31, 2021

The audited financial statements for the Canadian Amateur Rowing Association for the year ended March 31, 2021, were provided for your review and approval. The following is a summary of the year's results:

The excess of revenue over expenses for the year from operations was \$362,162 compared to our initial budgeted loss of \$2,029.

In the schedule 2 cost there is additional staffing cost due to 3 training centres and the deferral of the Tokyo Olympics & Paralympics. The events and camps as noted were not attended and the cost deferred and there was an increase in athlete support.

Many factors attributable to Covid impacted the net results. As we are all aware the Covid restrictions delayed the Olympics and Paralympics, cancelled regattas and events and restricted programs and initiatives.



We were fortunate to receive \$1,234,500 of Covid-19 Emergency Relief Funding and the initial wage subsidy grant for \$24,997. These funds allowed us to provide support to the domestic clubs and programs, support the cost of staff communications and working from home and the cost of the PPE requirements. They also allowed us to broaden our member communications and develop online initiatives and programs. The HP side was burdened with operating 3 programs at once, those being Tokyo 2020, Paris 2024 and Para Tokyo 2020 and the inability to utilize one facility; instead operating with 3 and in effect 3 athlete bubbles. The primary reason we have a surplus is that \$470,924 was spent in capital (see note 4) to broaden the operational assets to run the 3 HP groups. In 2021 \$100,949 was amortized on these assets and the residual will be amortized over the next 3-5 years.

With the cancellation of regattas and events we had a \$261,587 reduction in membership fees, no competition and camp registrations revenue, a drop of \$335,268 in events, fundraising and donations (such as conference etc.) and the sport association and foundations decline of \$129,568 (such as Henley Corporation and RBC Training Ground - which was deferred see below).

You will note that Sport Canada, Canadian Olympic Committee and RBC Training Ground revenue reduced by \$1,498,928 (note 5) as we were able to defer it to fiscal 2022. This is offset by the reduction in HP cost as no qualifying regattas (World Cups etc.) were attended in the summer of 2020 and the Olympics and Paralympics deferred to 2021.

The Governance and National Operations increase of \$\$95,373 is attributable to the PPE, other Covid workplace requirements, and Safe Sport legal cost.

our Fund's surplus.

Our Fund balances comprised of those Invested in Capital Assets, Internally Restricted and Unrestricted on March 31, 2021, were \$1,559,487.

For all the staff and athletes at Rowing Canada Aviron this was a very difficult year and without question they pulled together to produce a successful year financially, operationally, and internationally. We as members should be proud of this team at RCA and what it achieved.



## **GROW ROWING**

In 2021 RCA launched a series of initiatives and funding opportunities to assist our member organizations with their efforts to restore programming and to support their local community through rowing during the COVID-19 pandemic.

In addition to ensuring access to grant opportunities such as Canadian Tire Jump Start Relief (>\$110,000 granted to rowing clubs), RCA provided \$357,000 to the Canadian rowing community in the form of grants to support club programming and a safe return to competitions, and to cover the costs of extraordinary expenses related to COVID-19.

"RCA's emergency funding of our additional safety and cleaning supplies really bolstered our efforts to get our members back out on the water as soon as regulations permitted," says Karen Burnett, captain of the Vancouver Rowing Club's rowing section. "And the grant we received to add a stable single shell to our fleet when Learn-To-Row was singlesonly meant a dozen more people were introduced to our sport this summer, some of whom have since joined as full dues-paying members. We're grateful for RCA's creative and timely approach to funding during the COVID-19 emergency."

"The Guelph Rowing Club is incredibly grateful for the opportunity provided by the Jumpstart Sport Relief Fund. Before this grant application was approved we didn't have a club-owned single that was the right size for our lightweight women, and we've already seen it's impact on keeping young female athletes engaged in the sport. The "Jumpstart," as it was named by the club, was even rowed to a bronze medal at OUAs this fall by an athlete in her first year of varsity competition."

#### **National Come Try Rowing Day**

Held on Saturday June 26 and Sunday June 27, 2021, 28 clubs across the country hosted the inaugural National Come Try Rowing Day in conjunction with RCA and Provincial Rowing Associations. Over 750 new to rowing participants joined us on the water for free introductory Come Try rowing sessions.

#### **The Great Indoors**

As part of our goal to foster growth in multiple disciplines of rowing, RCA launched The Great Indoors initiative in February 2021 with a series of individual and team indoor rowing challenges supported by resources and training programs. A total of 263 individuals registered online, 101 (38% of all participants) of which were new to RCA. A set of new challenges and resources were launched in November 2021.

#### **RCA Grow Rowing Pilots**

The Grow Rowing Pilot Program looks beyond the 2021-2022 season to imagine how rowing in Canada can thrive post-COVID-19. RCA partnered with three organizations to pilot new programming that can be delivered nationwide that will diversify rowing in Canada to drive a significant increase in the number of Canadian rowers by 2025. Over 285 newClub and Provincial Rowing Association leaders will join RCA in assessing these pilots to identify learnings that will be shared with the entire Canadian rowing community in early 2022.

#### Argonaut Rowing Club -Oar Board Initiative

The Argonaut Rowing Club (ARC) will be working with RCA and Oar Board Canada to reduce barriers to entry for new rowers. Using the Oar Board SUP rowers, ARC will provide safe, inexpensive, fun and user-friendly introductory programs to people of all shapes, sizes and ages. The Oar Boards will also allow ARC to experiment in an entirely new arena: rentals to the general public.

#### False Creek Rowing Club – False Creek Community Rowing

The False Creek Community Rowing Program will create opportunities to welcome individuals from populations that are currently underrepresented in rowing, ensuring that the rowing club is representative of the 100,000 people living within a 10-minute walk of False Creek and the nearly 1 million living within a single public transit trip. The project will include working with nearby schools, people with autism, and youth in mentorship programs to both create exposure to rowing and increase long term participation in the sport. Several community partners have already been engaged to work with the program once allowed within pandemic restrictions.

#### Kingston Rowing Club -Row with us. Grow with us.

The 'Row with us. Grow with us' program is designed to take rowing out of the confines of the boathouse and bring coastal rowing into population centres for increased visibility. By utilizing coastalstyle rowing, reducing as many barriers as possible, and offering a series of low-cost, low-commitment events, Kingston Rowing Club will safely introduce an increasing number of new participants to the sport. This program will contribute to a healthy, active and engaged Kingston community.

#### NOTES TO FINANCIAL STATEMENTS - YEAR ENDED MARCH 31, 2021

#### 1. PURPOSE OF THE ASSOCIATION

Rowing Canada Aviron is the operating name of the Canadian Amateur Rowing Association -Association Canadienne d'Aviron Amateur (the "Association") which is a not-for-profit organization incorporated under the Canada Not-for-profit Corporations Act. As a not-for-profit organization, the Association is exempt from the payment of income tax.

As a Registered Amateur Athletic Association it is authorized to issue receipts for tax purposes for the donations it receives.

The Association's principal activity is the development of the sport of rowing in Canada and it is recognized by the Government of Canada and the Canadian Olympic Committee as the national governing body for the sport of rowing.

#### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### **BASIS OF PRESENTATION:**

The financial statements were prepared in accordance with Canadian accounting standards for not-for-profit organizations ("ASNPO"). As a result these financial statements are in accordance with Canadian generally accepted accounting principles ("Canadian GAAP").

#### **REVENUE RECOGNITION:**

The Association follows the deferral method of accounting for contributions.

Restricted contributions are recognized as revenue in the year in which the related expenses are incurred. Donation revenue is accounted for when received. Unrestricted contributions are recognized as revenue when received or receivable if the amount to be received can be reasonably estimated and collection is reasonably assured. Pledges from donors are recorded when payment is received by the Association or the transfer of property is completed. Donations received for the acquisition of property or to support future operations are recorded as deferred amounts.

Membership fees are recognized as revenue in the period of membership eligibility.

#### INTERNALLY RESTRICTED NET ASSETS:

Net assets that are internally restricted have been designated by the Association for specific uses. Internally restricted resources can be made available for other purposes.

#### CASH AND CASH EQUIVALENTS:

Cash and cash equivalents consist of cash on hand and balances with banks.

#### TANGIBLE CAPITAL ASSETS:

Purchased assets are stated at cost less accumulated amortization. Contributed assets are recorded at fair value at the date of contribution. Tangible capital assets are amortized over their estimated useful lives on a straight-line basis at the following rates:

#### FINANCIAL INSTRUMENTS:

The Association's financial instruments consist of cash and cash equivalents, accounts receivable and accounts payable and accrued charges. Financial instruments are recorded at fair value when acquired or issued. In subsequent periods, financial assets with actively traded markets are reported at fair value, with any unrealized gains and losses reported in income. All other financial instruments are reported at amortized cost, and tested for impairment at each reporting date. Transaction costs on the acquisition, sale, or issue of financial instruments are expressed when incurred.

#### **MEASUREMENT UNCERTAINTY:**

The preparation of financial statements in conformity with Canadian accounting standards for not-for-profit organizations requires management to make estimates and assumptions that affect the reported amount of assets and liabilities, disclosures of contingent assets and liabilities as at the date of the financial statements and the reported amounts of revenues and expenses during the period. Such estimates are periodically reviewed and any adjustments necessary are reported in earnings in the period in which they become known. Actual results could differ from these estimates. The Association's material estimates include the collectability of accounts receivable, deferral of revenue, accrual of accounts payable, and the useful life of tangible capital assets.

#### CONTRIBUTED MATERIALS AND SERVICES:

Donated tangible capital assets and rent is recorded at fair value when received if fair value can be reasonably determined.

The Association is dependent on the voluntary service of many members and other. Since these services are not normally purchased by the Association, and because of the difficulty of determining their fair value, donated services are not recognized in these financial statements.

- The Umpire's Reserve Fund relates to amounts raised by the 2001 World Masters Rowing Regatta Organizing Committee to be used for the education and development of umpires within Canada.
- The Sustainable Organization Reserve Fund provides a source of funds for future financial needs.
- A separate internally restricted fund has been established to accept donations for the National Training Centre in Quamichan Lake. The donations are restricted for expenditures of the Centre.

#### 9. FINANCIAL INSTRUMENTS

The Association is exposed to various risks through its financial instruments and has a comprehensive risk management framework to monitor, evaluate and manage these risks. The following analysis provides information about the Association's risk exposure and concentration as of March 31, 2021.

#### (A) CREDIT RISK

Credit risk arises from the potential that a counter party will fail to perform its obligations. The Association is exposed to credit risk from members. An allowance for doubtful accounts is established based upon factors surrounding the credit risk of specific accounts, historical trends and other information. The Association has a significant number of members which minimizes concentration of credit risk. The credit risk regarding cash and term deposits is considered to be negligible because they are held by a reputable financial institution with an investment grade external credit rating.

#### (B) LIQUIDITY RISK

Liquidity risk is the risk that an entity will encounter difficulty in meeting obligations associated with financial liabilities. The Association is exposed to this risk mainly in respect of its receipt of funds from its funders, members and other related sources, and accounts payable and accrued charges.

#### (C) MARKET RISK

Market risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market prices. Market risk comprises three types of risk: currency risk, interest rate risk and other price risk. The Association is mainly exposed to currency risk.

Unless otherwise noted, it is management's opinion that the Association is not exposed to significant interest rate risk or other price risks arising from these financial instruments.

#### (I) CURRENCY RISK

Currency risk is the risk to the Association's excess of revenue over expenses that arise from fluctuations of foreign exchange rates and the degree of volatility of these rates. The Association is exposed to foreign currency exchange risk on accounts payable held in foreign denominations. The Association does not use derivative instruments to reduce its exposure to foreign currency risk.

#### **10. LEASE COMMITMENT**

The Association entered into a lease agreement in the year for a training facility with an expiry date of December 31, 2022. The lease agreement has an option to renew the lease by October 1, 2021 for an additional one year to a maximum of three additional years or five years in total.

The Association's total future minimum lease payments under operating lease commitments over the next two years are as follows:

In addition to the above noted minimum lease payments the Association is also obligated to pay their share of operating costs, which fluctuate year to year.

#### 11. COVID-19 EMERGENCY **RELIEF FUNDING**

On June 19, 2020 the Association received \$1,234,500 from the COVID-19 Emergency Relief Fund for Cultural, Heritage and Sport Organizations administred through Heritage Canada. The goal of the Fund was to ensure business continuance for organizations whose viability was negatively affected by COVID-19. The funds were expended by March 31, 2021 as follows:

#### 12. IMPACTS OF COVID-19

Since December 31, 2019, the spread of COVID-19 has severely impacted many local economies around the globe. In many countries, including Canada, businesses were forced to cease or limit operations for long periods of time. Measures taken to contain the spread of the virus, including travel bans, quarantines, social distancing, and closures of non-essential services have triggered significant disruptions to businesses worldwide, resulting in an economic slowdown. Global stock markets have also experienced great volatility and a significant weakening. Governments and central banks have responded with monetary and fiscal interventions to stabilize economic conditions.

In response to the spread of COVID-19, Sport Canada and COC have amended the term of the existing funding agreements for fiscal 2021 to extend the period for which eligible expenses may qualify for funding to September 2021. In addition, travel restrictions imposed by the pandemic have resulted in cancelled trips and lost travel deposits to date.

The duration and impact of the COVID-19 pandemic, as well as the effectiveness of government and central bank responses, remains unclear at this time. It is not possible to reliably estimate the duration and severity of these consequences, as well as their impact on the financial position and results of operations of the Association for future periods.
