6. CEO Update

Athlete Safety Review:

A review of the High Performance Environment by ITP Sport has been completed. The recommendations as a result of the review are currently being implemented.

3rd Party Complaints:

Independent 3rd Party Complaints will no longer be dealt with by ITP Sport. Lise MacLean will take over that role and ITP Sport will continue to assist RCA in other areas.

World Cup Events:

As a result of the current conflict in Eastern Europe, issues around the safety of hosting Rowing World Cup events in that area have been discussed among a number of federations.

Relief Funding:

RCA's Relief Funding application for the 2021-22 fiscal year has been approved. An application has also been submitted the 2022-23 with a focus on participants with limited access to rowing programs.

Fundraising for the Ukraine:

Athletes have raised a considerable amount funds as a donation to the Canadian Red Cross.

In kind immigration support to a family has also been provided by RCA.

High Performance Coaches:

The importance of hiring of additional female coaches was discussed.
