- d. any additional evidence of eligibility for membership that the Board of Directors of CARA considers reasonably necessary.

3.2 Acceptance of Membership Application

Members shall be accepted into membership in CARA on approval of their application by Ordinary Resolution of the Board of Directors at any Board of Directors meeting if the Board is satisfied that the applicant's membership will contribute to CARA's purpose and objectives and subject to the additional requirements of paragraph 3.3. The Board retains the sole discretion to accept or reject an applicant for membership.

3.3 Additional Requirements

- a. All applicants for membership within CARA must, as a condition of application of maintaining membership in CARA (if granted) agree to follow the Bylaws, policies and regulations of CARA and adopt CARA's safe sport policies, as amended from time to time, unless precluded from doing so as a result of provincial or territorial legislation and/or provincial or territorial funding requirements.
- b. An applicant that is a Provincial Rowing Association must be recognized by the government of its province or territory as being the governing body for the sport of rowing in its province or territory.
- c. An applicant that is a Rowing Club, or a Special Association operating wholly within the borders of a particular province or territory, must have the endorsement of the applicable Provincial Rowing Association.
- d. In the case of an applicant that is a Special Association the Board of Directors may stipulate the terms and conditions of membership in CARA.

- d. any additional evidence of eligibility for membership that the Board of Directors of CARA considers reasonably necessary.

3.2 Acceptance of Membership Application

Members shall be accepted into membership in CARA on approval of their application by Ordinary Resolution of the Board of Directors at any Board of Directors meeting if the Board is satisfied that the applicant's membership will contribute to CARA's purpose and objectives and subject to the additional requirements of paragraph 3.3. The Board retains the sole discretion to accept or reject an applicant for membership.

3.3 Additional Requirements

- a.
